A BYLAW TO REGULATE HOUSE NUMBERING IN THE SOOKE FIRE PROTECTION DISTRICT OF THE ELECTORAL AREA OF SOOKE

WHEREAS Sooke Numbering of Buildings Bylaw No. 1, 1992 establishes House Numbering in the Sooke Fire Protection District of the Electoral Area of Sooke in the Capital Regional District,

NOW, THEREFORE, the Regional Board of the Capital Regional District in open meeting assembled ENACTS AS FOLLOWS:

INTERPRETATION

1. For the purpose of this bylaw:

"Building" means any dwelling; business premises, hotel, apartment house, barn, shed or any other shelter.

"District" means the Trustees of the Sooke Fire Protection District.

"Street" means highway, road, lane or public thoroughfare.

"Street number" means the numbers allocated by the District for the purpose of numbering buildings.

DELEGATION OF AUTHORITY

2. The administration of this bylaw is delegated to the District.

3. The enforcement of this bylaw shall remain with the Capital Regional District.

4. All buildings in the Sooke Fire Protection District shall bear a street number, except outbuildings and auxiliary buildings on the same lot as the main building.

REQUIREMENTS

5. An owner of property who applies for a building permit shall also apply to the District for a street number, and the street number shall be affixed and displayed in accordance with this bylaw.

6. (1) An owner of a building upon receipt of his or her official street number shall affix the number within thirty days in a secure position within thirty (30) feet of the property line bordering on the nearest street.

(2) The numbers shall be not less than three inches in height and shall be visible from the street in front of the building.

PENALTY

- 7. (1) A person found guilty of a contravention of this bylaw is punishable in accordance with the Offence Act, and subject to a minimum fine of \$100.00.
- (2) A separate offence shall be deemed to be committed upon each day on which the contravention occurs or continues.

CITATIONS


- 8. This bylaw shall be cited as the "Sooke House Numbering Bylaw No. 1, 1993".


