

## DISTRICT OF SOOKE

### BYLAW No. 334

---

A housekeeping bylaw to amend Bylaw No. 1473, *Deposit of Soil, Prohibition Bylaw No. 2, 1986* to add bylaw enforcement regulation.

---

The Council of the District of Sooke, in open meeting assembled, enacts as follows:

1. This Bylaw is cited as *Deposit of Soil Amendment Bylaw (1473-1)*.
2. Bylaw No. 1473, *Deposit of Soil, Prohibition Bylaw No. 2, 1986* is amended by deleting section 10 and replacing it with the following:
  - “10. **Offence and Penalty**
    - 10.1 Every person who contravenes any provisions of this bylaw commits an offence punishable upon summary conviction and is liable to a fine not exceeding \$10,000.00 as set out in the *Offence Act*.
    - 10.2 If an offence is a continuing offence, each day that the offence is continued constitutes a separate and distinct offence.
    - 10.3 This Bylaw may be enforced by means of a ticket in the form prescribed for the purpose of section 264 of the *Community Charter*.
    - 10.4 Bylaw Enforcement Officers, Building Inspector or Official and the Director of Engineering are designated to enforce this bylaw pursuant to section 264(1)(b) of the *Community Charter*.
    - 10.5 The words or expressions set forth in Column 1 of Schedule A of this bylaw are authorized pursuant to section 264(1)(c) of the *Community Charter* to designate the offence committed under the bylaw section number appearing in Column 2 opposite the respective words or expressions.

- 10.6 The amounts appearing in Column 3 of Schedule A of this bylaw are the fines established by Council pursuant to section 265(1)(a) of the *Community Charter* for the corresponding offence designated in Column 1.”
3. Bylaw No. 1473, *Deposit of Soil, Prohibition Bylaw No. 2, 1986* is amended by adding *Schedule D – Municipal Ticket Information Designations* as set out in Schedule 1 of this bylaw.
