DISTRICT OF SOOKE MUNICIPAL TICKET INFORMATION BYLAW BYLAW No. 836

A bylaw to implement a Municipal Ticket Information System for bylaw enforcement.

The Council of the District of Sooke, in open meeting assembled, enacts as follows:

Citation

1. This Bylaw is cited as "Municipal Ticket Information Bylaw No. 836, 2022."

Designated Bylaws

 The bylaws listed in column 2 of Schedule A of this bylaw may be enforced by means of a ticket in the form prescribed for the purpose of section 264 of the Community Charter.

Designated Bylaw Enforcement Officers

3. The persons who act in the positions listed in column 3 of Schedule A of this bylaw are designated as Bylaw Enforcement Officers for the purpose of enforcing the bylaws listed in column 2 of Schedule A opposite the respective positions.

Offences

4. The words or expression set forth in Column 2 of Schedules B1 through B19 of this bylaw designate the offence committed under the bylaw section number appearing in Column 1 opposite the respective words or expressions.

Fine Amounts

5. The amounts appearing in Column 3 designate the fines for contraventions of the bylaw offences set out in Column 2 of Schedules B1 through B19.
