- Applicants must remit Damage Deposit (\$300.00) upon application (refundable)
- Applicants must pay a \$50.00 administration fee (non-refundable)
- Applicants must pay a monthly Food Truck Permit fee of \$250 per month, on the first of the month.
- Applicants must agree to work in the assigned park.
- Food Truck vendors must supply a trash can and remove contents from park.
- Packaging waste should be compostable where possible.
- Liquor is not to be sold, given, or otherwise provided or consumed.
- Vendor's schedule is Monday to Sunday, in each assigned park (do not have to work each day)
- Vendors cannot work prior to 10:00 a.m. or after dusk.
- Radios or other amplification; must not be heard beyond 20 feet of the Food Truck.
- Food Trucks must not park or obstruct Fire Lane or accessibility parking.

I _____ agree to the above terms and conditions. I understand that any violations of the District of Sooke's Bylaws may result in suspension or revocation of the Food Truck Service in Parks Permit.
